- Coordination, assembly and submission of financing applications for residential development projects
- Presenting proposed residential development projects as necessary for internal and external review and approval
- Support the negotiation of financing and investment terms for residential development projects
- Manage Project closings on behalf of owner/client, including coordinating the completion due diligence checklists among multiple parties
- Construction monitoring and reporting to financial parties during construction stage
- Work with investors, lenders, and others to meet project deliverables, equity installments requirements, project close out, compliance and similar.
